



Expenses were greater than revenues in 2018 primarily due to the disbursement of restricted contributions received in previous years. In 2018 the Architects Foundation recorded a net expenditure of \$114,311 for direct grant and scholarship payments. The Architects Foundation measures its financial sustainability primarily based on its change in net assets without donor restrictions. In 2018, the Foundation recorded an increase in net assets without donor restrictions of \$29,910.

SCHOLARSHIP PROGRAMS

In 2018, we laid the groundwork for the growth of our scholarship programs, actively administering, developing, and taking on scholarship programs that support and empower architects at different career stages—stages that often end up being barriers to professional success as an architect. We also began to develop new ways to engage and empower our growing family of scholars.

Last year, we awarded \$432,600 in scholarships. And we more than doubled the number of scholarship programs to better support the career pipeline.

THE OCTAGON

As the first home to The American Institute of Architects in Washington, DC, The Octagon symbolizes both historic architectural significance and the value architects and architecture bring to culture and social impact.

Events

We hosted visitors at The Octagon for special events and meetings, helping to expand the museum's visitor base. The Octagon maintains a decades-long relationship with the Historical American Building Survey, partnering on summer internship events, and the Association for Preservation Technology continues to hold lectures and meet-ups in the building.

Last fall, the museum had the honor of hosting a brunch for the "Black Women in Architecture" group as part of a National Museum of African American History and Culture symposium titled "Shifting the Landscape: Black Architects and Planners, 1968 to Now."

Recent exhibits

50 Years After Whitney Young Jr.

Jointly curated by AIA, The Octagon, and the Architects Foundation, the "50 Years After Whitney Young Jr." exhibit explored civil rights leader Whitney Young and his impact on the architecture profession five decades after his keynote speech at the 1968 AIA National Convention, where he challenged architects to address social issues.

The exhibit—which included a detailed companion website that remains live today—commemorates Young and recognizes the architects and organizations who tirelessly advocate and champion social issues. The show subsequently traveled to AIA Portland in fall 2018 and will be on view at AIA San Francisco and AIA Dallas in summer 2019.

Victor Lundy: Educating an Architect + Preserving Modern Architecture

This special exhibit offered a once-in-a-lifetime opportunity to view drawings and paintings from the private collection of an influential American architect. A leader in the Sarasota School of Architecture, Lundy designed renowned modernist buildings, including the US Embassy in Sri Lanka and the US Tax Court Building in Washington, DC. Curated by Houston-based architect and academic Donna Kacmar, FAIA, this unique exhibit was on view at The Octagon through February 2019 prior to being catalogued at the Library of Congress.
